Dear Mr. Pollak:

This is in response to a Freedom of Information Act (FOIA) request (Attachment 1) submitted to the Defense Security Service (DSS) by a Mr. Michael Ravnitzky, American Lawyer Media.

This Directorate considers all FOIA requests made by Mr. Ravnitzky to DSS on American Lawyer Media (ALM) letterhead to be the property of ALM and not that of Mr. Ravnitzky. Accordingly, DSS will send our responses to these requests directly to ALM.

Enclosed (12 pages) (Attachment 2) is a copy of all releasable documents responsive to ALM's request. Where blacked out and noted within the documents, information has been withheld that is exempt from the mandatory disclosure provisions of the FOIA for the following reasons:

a. Exemption (b)(6) is used to protect personal information, any release of which would constitute a clearly unwarranted invasion of another individual's privacy.

Aside from the enclosed material, no additional records responsive to your request were located. Since this constitutes a partial denial of your request, we are required to inform you that ALM is entitled to file an administrative appeal if you so desire. Appeals should be directed in writing to the Director, Defense Security Service, Attn: Office of FOIA/PA, 1340 Braddock Place, Alexandria, VA 22314-1651. In any such appeal, you should also provide a copy of this letter, along with sufficient justification upon which the Director may base a decision.

Your correspondence indicates that you have requested this information to help inform the public on how the FOIA program is being carried out within DSS. Although it is

unclear to the DSS how ALM is going to obtain an accurate assessment of our program based solely on this request, should you have any questions concerning our FOIA program, please feel free to contact my office at (703) 325-9450 or our Office of Public Affairs. I would be glad to discuss our FOIA program at any time.

Hello to All,

This office recently received via Jay Fraude (forwarded to him by Beth Kraus), a copy of an email apparently authored by one Mr. Michael Ravnitzky.

As a short background: Mr. Ravnitzky was a reporter with the now defunct internet news site of APB News, Inc. APB News filed for bankruptcy in approximately the 2000/2001 timeframe. However, previous to that timeframe, Mr. Ravnitzky on behalf of APB News, filed several FOIA requests seeking DoDPI information amongst other Agency documents and information. Previous to the banktupcy filing, one of the FOIA requests which he filed was for a copy of the DODPI videotape listing (which was released). And now, I do believe that is the list which he has either placed on a website or is circulating in some other manner.

To date, I have received several telephone calls regarding this list and 2 formal written FOIA's requesting several tapes. (Beth/Genni - I will forward these later for your review) I have explained to the telephonic inquiries that (a) Mr. Ravnitzky is incorrect when he says "None of these tapes is classified" because though they may not be deemed "classified" in the definition of the word, there's a possibility they may not be releasable for other reasons; (b) Informed them that there may be a substantial fee involved for the review, duplication, etc.; and (c) There may also be a substantial amount of time involved in the review/duplication of any of these tapes, before actual release.

After consultation with Les, it was determined that it may be in the best interest of all involved if those tapes that are no longer utilized by DODPI for any reason, be destroyed in accordance with the DODPI or DSS records retention regulation.

Further, for those tapes that are reviewed and deemed releasable to the public, multiple copies would be made and a listing of only the releasable tapes would be placed on the DSS public website specifically stating that those are the only tapes available for release to the public, and should the requester wish to receive a copy, to contact DODPI directly. This would sway many requesters if they actually saw first hand what is releasable without actually having to file a direct FOIA request. In the longrun it would mean less work and headaches for everyone involved.

For those of you who receive FOIA requests from Mr. Ravnitzky, you know that there has been much discussion lately on whether he should be considered an "other" or a "media" requester. Specifically, the issue is that even though he works for what seems to be a legitimate media organization (American Lawyer Media), it appears that they have not disseminated any of his requested information. As many of you know, DOJ OIP has taken up this issue with him and his employers. Concerning one specific request that he has with DOJ, he has been granted media status (NOT a fee waiver, however) because his employers have promised to DOJ that they will disseminate what he requests.

Concerning FOIA requests from Mr. Ravnitzky, this Directorate is taking the view that unless American Lawyer Media spells out how they intend to disseminate the information that he requests, he will be considered an "other" requester. This determination will be made on a case-by-case basis. For our requests hanging around from his pre-American Lawyer Media days, we will consider him as other.

This guidance is provided to assist you in your efforts to classify Mr. Ravnitzky as a FOIA requester. It is not policy. Our specific policy is spelled out in DoD 5400.7-R. If you have any questions, please call me. For those agencies who receive this message after it was forwarded from a parent component, please contact your component for guidance.
